## **POSITION DESCRIPTION**

Landcare is a unique community-based approach to managing and restoring Australia's natural environment, improving the sustainability of agricultural activities, and building the resilience of communities. A common thread is the ethos of an enabled community addressing the challenges of ecologically sound and productive use of our natural resource base. Landcare is an Australian icon and has a proud history of 30 years of making a difference to local and regional communities. The Local Landcare Coordinators Initiative is funded by the NSW Government and is supported through the partnership of Local Land Services and Landcare NSW. The role is based in Holbrook but will work closely with Murray Landcare colleagues, Murray Local Land Services and local communities and groups in the Eastern Murray region wanting to establish sustainable agriculture, environmental or rural community development activities.

Holbrook Landcare Network is a Not-for-Profit community network based in southern NSW. It is a highly regarded and vibrant rural organization, with a thirty-two year history of managing sustainable agriculture and natural resource management projects.

HLN's goal is to be an independent, regionally relevant, professional and vibrant network, providing information and support to producers and communities, to enable informed and evidence-based decision making, with a focus on the high rainfall mixed farming zone.

The Local Landcare Coordinator position will work under the direction of the Holbrook Landcare Network Executive Officer. Early career and people from diverse backgrounds are encouraged to apply.

#### Duties include:

- I. Work with Landcare Groups to:
  - improve their capacity to support and increase community engagement
  - extend their coverage to provide support to more community groups and landholders
  - undertake planning, develop partnerships and secure resourcing through project grants and other sources
  - monitor evaluate and report on projects and activities
  - improve their long-term financial stability and viability by sourcing external funds
  - effectively participate in natural resource management activities that address critical agricultural sustainability and environmental issues
  - link to programs of Local Land Services and other Government agencies and organisations to develop onground natural resource management projects, in line with regional and state strategies
- II. Participate in a State-wide Coordinators Network and Regional Community of Practice events
- III. Work as part of a team to carryout community engagement, the development of funding proposals, implementation of communication plans and on-ground activities for a wide range of projects in sustainable agriculture and/or natural resource management across the Eastern Murray region.
- IV. Support the Executive Officer to monitor budgets, develop communications and report on projects as necessary to funders and the community.
- V. Other duties as required

### Key Competencies: The preferred applicant will possess the following personal competencies

- Be proactive with a community minded attitude
- Have excellent networking and people skills
- Have good communication, coordination, administration and computing skills
- Have a strong interest in and commitment to local environmental, sustainable agricultural and community development issues
- Can manage their time and workload effectively

#### **Additional Information**

- Flexibility in working hours may be required at times to attend meetings and work on activities outside of normal work hours. Additional hours over the standard 37.5 hours will attract a *time in lieu* arrangement.
- The position may involve some travel around the region and, very infrequently, overnight stays may be required.

#### SELECTION CRITERIA – Applicants must supply claims of suitability against each of the listed selection criteria.

#### Essential

- 2. High level interpersonal skills including demonstrated ability to work with and develop community groups, including group facilitation, action planning and negotiation with diverse stakeholder groups including farmers, general community, researchers and government agencies.
- 3. Demonstrated ability in project planning, project management, record keeping and report writing.
- 4. Ability to work effectively in a team environment to achieve project and community outcomes.
- 5. Well-developed written and oral communication skills, including competence in the use of Microsoft Office suite, email and online systems.
